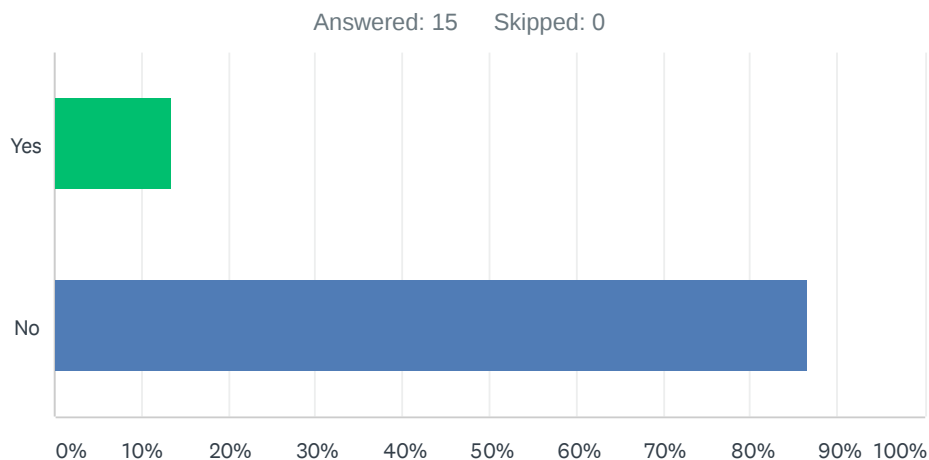


## Will your Head Start program be reopening on June 15, 2020 for in-person services and programming?

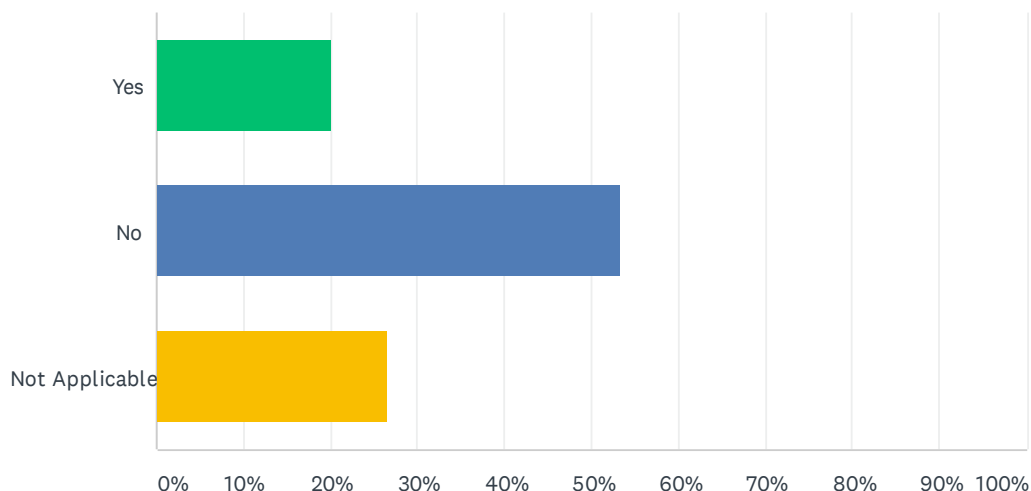

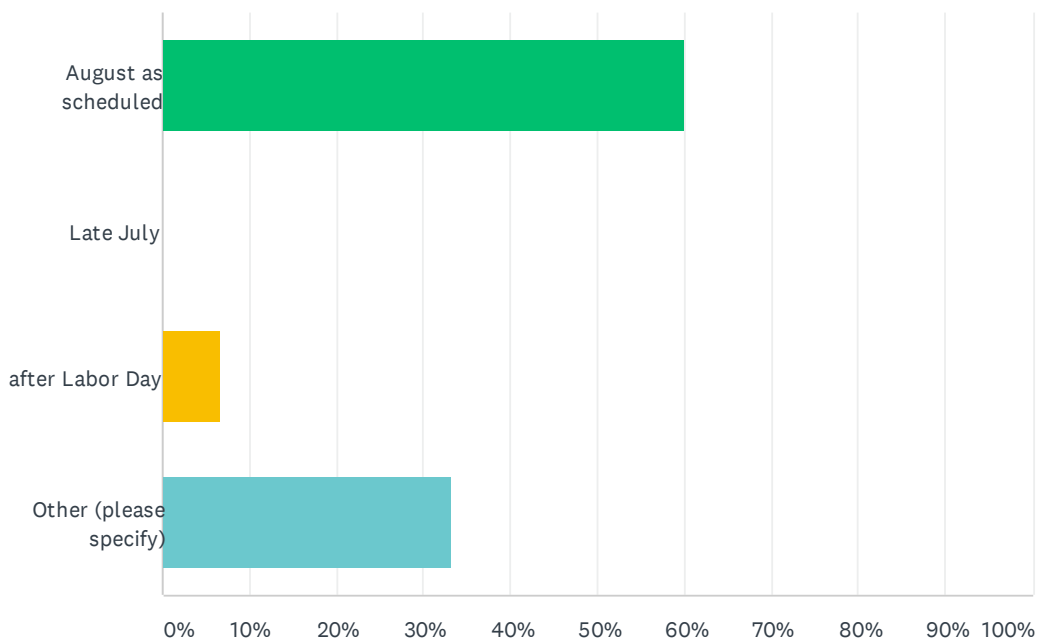

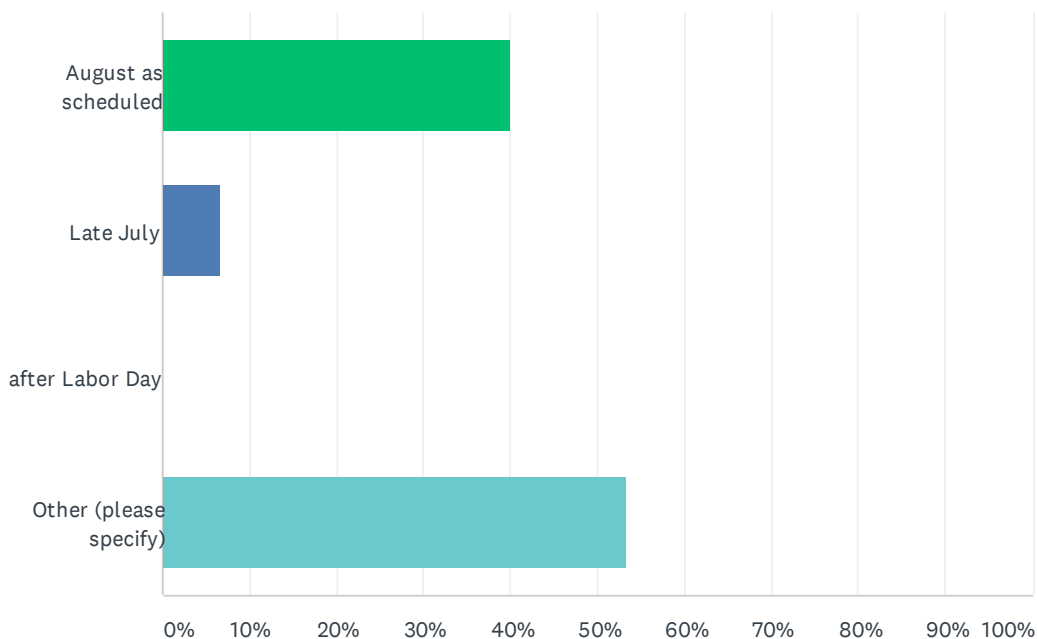
